You are, therefore, requested to kindly place the matter before Hon'ble the Chief Justice for sparing of the Judicial Officers & Ministerial Staff to attend the Training Programmes according to the schedule annexed herewith. Judicial officers who are going to superannuate within one year from the scheduled date of their training may not attend training.

While sparing the participant officers, letter no. 24348 dt. 29/04/2015 of Hon'ble Patna High Court as regards to number of officers to be spared from one station has been adhered. However, keeping in view the remaining number of training programmes and remaining number of judicial officers, at some places the number may vary which may kindly be considered for the approval.

The participants officers may be directed that in case of Annual General Transfer/Mid Term Transfer the officers are supposed to report at Bihar Judicial Academy for their respective training sessions from their new place of posting, as per present schedule only. The participant officers may also be directed to report at Bihar Judicial Academy on 09:30 A.M. sharp on due date of their training session.

They may further be directed to come in proper dress. Hostel facility and mess facility shall be provided to them.

Note: As directed, this is to request to all the Learned District & Sessions Judge to communicate all the Judicial Officers of their respective judgeships that they should not fix the record on the scheduled date of their training.
