## **NOTICE**

**With regard to filling up of the vacancies in the cadre of District Judge (Entry Level), against 10% quota for the year 2023-24.**

In Continuation of the Court's Notice dated 04.08.2025, this is for information to all the concerned that the written examination for promotion to the cadre of District Judge (Entry Level), under 10% quota for the year 2023-24 against 16 vacancies shall now be held on **12.10.2025 (Sunday)** in two sittings, 1<sup>st</sup> sitting from 10:30 A.M. to 1:30 P.M (Law Paper) and the 2<sup>nd</sup> sitting from 3:00 P.M. to 5:00 P.M. (Judgment Writing) in the premises of the Patna High Court, Patna.

Further that Law Paper shall comprise of 30% objective questions of multiple choice type and 70% descriptive type questions. The objective questions shall be answered on OMR Answer sheets. Further, BNSS, BSA and BNS have also been added in the syllabus already communicated for the aforesaid 14<sup>th</sup> Limited Departmental Competitive Examination.
