Being aggrieved by the impugned judgment and order dated 27.07.2018 passed by the learned Single Judge in CWJC No. 13754 of 2018 dismissing the said writ petition, the original petitioner has preferred the present Letters Patent Appeal.



We have heard learned counsel appearing for the parties. Number of submissions have been made by the learned counsel appearing on behalf of the appellant on merits, more particularly, on the aspect of the land offered by the petitioner comes under Mouza Uganwan and, therefore, the authorities was not justified in refusing to allot/grant the licence for opening of L.P.G. Distributorship. However, it is required to be noted that it is not in dispute that during the pendency of the proceedings the licence for L.P.G. Distributorship for the year has already been allotted and given to another person belonging to the same category and, therefore, third party rights are created.

Therefore, the only remedy available to the appellant-writ petitioner would be to file a suit for damages. In case the appellant-original writ petitioner is still aggrieved, more particularly when the third party in whose favour now the L.P.G. Distributorship is given is not before the Court.

Under the circumstances on the aforesaid ground alone, the present appeal stands dismissed.
