The applications in the prescribed format is invited from persons having adequate experience in Public Utility Services (Transport service for the carriage of passengers or goods by Air, Road, or Water or Postal, Telegraph or Telephone service; or Supply of Power, light or water to the public by any establishment; or system of public conservancy or sanitation; or service in hospital or dispensary, or insurance service, or banking service, or education or educational institutions; or housing and real estate services) for filling up the post of "Other Persons" (Members), PLA of district **Araria, Madhepura, Kishanganj & Jamui of Bihar.**

### Number of Post:- 02 (Two)

#### 1. Eligibility Criteria/Qualification:

(A) Essential Qualification: Person having **adequate experience in Public Utility Services**

(B) Desirable Qualification: Preference will be given to the Retired Govt. Officials from Public Utility Services, Department.

2. Tenure: The appointment shall be for a period of 5 years or 65 years of age, whichever is earlier.

3. Age: Age of candidates should be below 65 years as on 31.05.25

4. Service Condition:- All other terms and conditions of service of Other Persons (Members) shall be as per **"The Permanent Lok Adalat (Other Terms and Conditions of Appointment of Chairman and Other Persons) Rules, 2003"** and instructions issued from time to time by the State Authority.

5. Disqualifications:- A person shall be disqualified for appointment as a Other Person, if he/she;

- has been convicted and sentenced to imprisonment for any offence; or
- has been adjudged as an insolvent; or
- is of unsound mind and stands so declared by a competent court; or
- is in active politics.

6. Entitlements:- As permissible under the Rules, amended from time to time.

7. Mode of Application:- Interested candidates may apply online in the enclosed Proforma from 08.05.2025, 2025 (from 9:00 A.M. onwards) to 28.05.2025, (11.00 P.M.) on the website of the Authority.

8. Mode of Selection:- The Selection shall be made on the basis of performance in the Viva-Voce test (Interview) of the candidates.

**Note:**

1. The selected candidates will be required to undergo a medical fitness test by a Medical Board to be constituted for the purpose comprising Civil Surgeon-cum-Chief Medical Officer or Assistant Civil Surgeon-cum-Assistant Chief Medical Officer.
2. Before appointment, the candidate will undertake that he/she does not and will not have any such financial or other interest as is likely to affect prejudicially his/her functions as Other Persons (Members).
3. All announcements/ declarations regarding the recruitment process will be uploaded on the official website of Bihar State Legal Services Authority i.e. <http://patnahighcourt.gov.in/bslsa/>, from time to time, candidates are advised to keep visiting the said websites regularly; the Authority shall not be responsible for any kind of failure on the part of the candidate for not visiting the official website from time to time.
