## NOTIFICATION

The 26<sup>th</sup> March, 2026.

**No. 273-A :** The Judicial officers of the rank of Civil Judge (Senior Division), named in column no. 2 of the table given below, are hereby transferred and posted in the Judgeship to be stationed ordinarily at the station as mentioned in column no. 3 of the table against their name.

Further, in exercise of the powers conferred under Sub Section (3) of Section (11) of the Code of Criminal Procedure, 1973 (Act 2 of 1974) / Sub Section (3) of Section (9) of 'Bharatiya Nagarik Suraksha Sanhita, 2023', the High Court is pleased to confer upon the Officers named below the powers of a Judicial Magistrate of the 1<sup>st</sup> Class for the concerned District, provided that they shall work in such a way that their disposal of Civil and Criminal matter must be in the ratio of 30:70.

*Senior most Civil Judge (Senior Division) excluding Civil Judge (Senior Division)-cum-C.J.M. at the station and those officers who have not been found fit for promotion to the higher post shall be designated as Civil Judge (Senior Division)-I-cum-A.C.J.M.-I in the light of 'Bharatiya Nagarik Suraksha Sanhita, 2023' after effecting the above transfer & posting subject to approval of the Hon'ble Court.*

*The officers concerned may be directed to make over the charge of their present Office & Court immediately on receipt of this notification so as to join their new assignment soon thereafter].*

*{The matter related to posting of more Civil Judge (Senior Division)-cum-A.C.J.M. at Kishanganj, Sikrahna at Dhaka (East Champaran) and Gaya stands deferred until fresh appointments to the post of Civil Judge (Senior Division) by way of promotion are finalized}.*

*(The representation dated 06.03.2026 of Priti Anand stands allowed as last indulgence and the representation dated 28.02.2026 of Ms. Smita Kumari, Civil Judge (Sr. Div.)-cum-A.C.J.M., Hajipur (Vaishali) so far as it relates to her transfer back to Patna stands rejected.)*
