## STENOGRAPHER RECRUITMENT EXAMINATION, 2025

### NOTICE

**No.- 07/R&A**

**Dated: 30<sup>th</sup> January, 2026**

The Computer Based Written Test comprising English Shorthand-Computer Typing Test, Multiple Choice Question based Objective Test and English Computer Typing Test for the **Stenographer Recruitment Examination, 2025** (under Advertisement No. **PHC/02/2025**) was conducted on 22<sup>nd</sup> December, 2025 (Monday) in three shifts at various test centres in **Patna**. Altogether, 6032 candidates appeared at the said test. Two candidates (bearing Roll No. HCST2500548 and HCST2500915) from amongst these have been excluded from the result, since they were underage in view of clause 2(v) of the advertisement which clearly specifies that a candidate must not be born later than 01.01.2007 and so also their candidature stand cancelled.

Candidates who have secured minimum qualifying marks (as prescribed in Syllabus and Scheme of the advertisement) in the Written Test and are within the limit of three times seats against vacancy advertised in each category of reservation (as prescribed in the Advertisement), as per their availability, have been taken into consideration (merit wise) for preparation of the result. Thus, altogether 210 candidates, following the reservation roster criteria (as advertised), have been shortlisted and so are hereby declared qualified for appearing at the next stage i.e. interview of recruitment exercise.

Names of the shortlisted candidates in order of their Roll Number are enclosed herewith at **Annexure-I**.

The Cut-Off marks for each category is as follows:

**Note:-** Cut-off has not been mentioned for such categories where candidates of such category in requisite number were not available.

Besides, the candidates, whose roll number does not appear in the above mentioned enclosures i.e. Annexure-I, have either not secured qualifying marks or have secured marks less than the cut-off marks of their respective category.

Prior to appearing in the Interview, candidates shall mandatorily undergo Document Verification. Candidates must ensure that all requisite certificates/documents to substantiate their candidature, as per their application, are kept ready prior to the scheduled date of interview. They are further advised to carefully read the Advertisement in detail.

Any candidate who fails to produce the Domicile Certificate and the Caste/Category/NCL/Income & Asset Certificate, as prescribed in the advertisement, shall not be entitled to the benefits of reservation. Such candidates shall be treated as Unreserved (UR) category candidates, and their candidature shall be assessed under the Unreserved category across all stages of the current recruitment exercise.

Candidates claiming candidature under the OH category shall undergo a medical examination by a Medical Board, so constituted at the time of the interview, for determining the nature and percentage of disability/disabilities.

Candidature of the shortlisted candidates shall be provisional, subject to their being found eligible in all respects in accordance with the provisions of the advertisement and the relevant rules. If, at any stage, it is found that a candidate does not fulfill any of the eligibility conditions notified in the advertisement, his/her candidature shall be cancelled.

The date and schedule of interview of these candidates will be announced shortly on the official website of the Court. The Admit Card for appearing at the interview will be made available in due course, which may be downloaded from the official website of the High Court i.e. <https://patnahighcourt.gov.in/notices/recruitments>.

Admit Card would not be sent to the candidates separately through any other mode. The shortlisted candidates will be intimated through e-mail/SMS on their registered e-mail ID/mobile number in this regard.

No request for change in the schedule of interview shall be entertained.

The candidates are advised to keep visiting the Court's official website regularly for further details / updates.
