National Conclave on Technology and Judicial Education: High Court of Sikkim



The High Court of Sikkim successfully hosted the **National Conclave on Technology and Judicial Education** on 1st and 2nd of May 2026, bringing together distinguished judges, judicial officers, policymakers, academicians, technology experts and representatives from judicial

academies and institutions across India and abroad. The conclave served as a significant forum for deliberation on the transformative role of technology in judicial administration, capacity building and the future of justice delivery.

Over the course of two days, participants engaged in enriching

discussions, panel sessions and expert presentations on a wide range of contemporary themes, including the digital transformation of courts, judicial education in the age of emerging technologies, artificial intelligence and its implications for the justice sector, e-Governance initiatives, cybersecurity, digital infrastructure, data management and the future of technology-enabled dispute resolution. The exchange of ideas and best practices facilitated meaningful collaboration among courts, judicial academies, government institutions and technology stakeholders, contributing to the advancement of a modern, efficient, transparent and citizen-centric justice delivery system.

The conclave also provided an opportunity to showcase innovative digital initiatives undertaken by various High Courts and judicial

institutions. Deliberations highlighted the importance of strengthening digital literacy, enhancing technological capacity within the judiciary and fostering institutional preparedness to effectively harness emerging technologies while safeguarding judicial independence, privacy and data security.

A landmark highlight of the conclave was the historic declaration of **Sikkim as the first paperless state judiciary in the country** by Hon'ble Mr. Justice Surya Kant, Chief Justice, Supreme Court of India on 1st May 2026. This achievement reflects the State Judiciary's steadfast commitment to digital innovation and sustainable judicial administration.

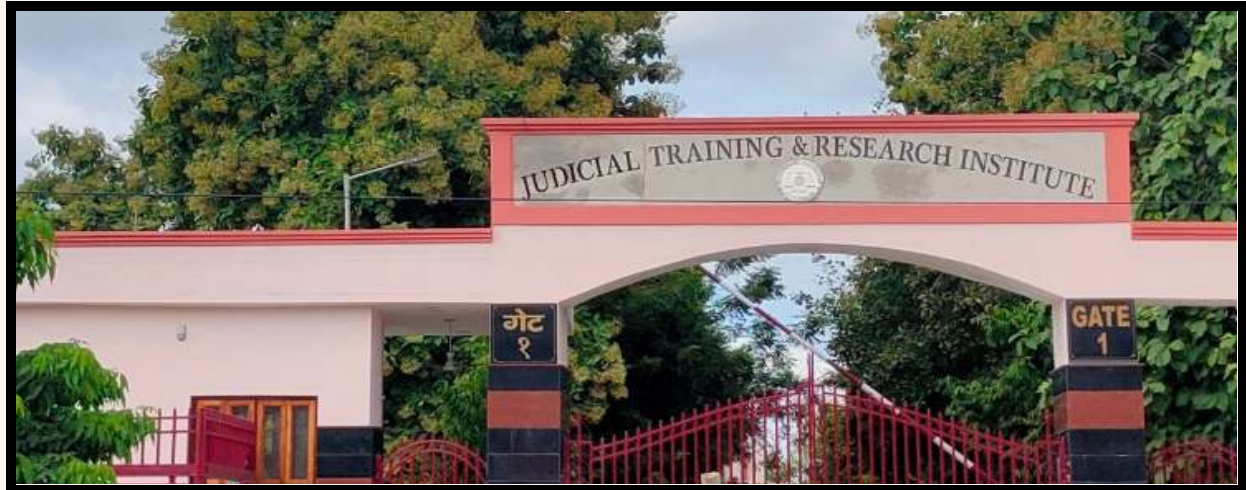

Judicial Training & Research Institute, Uttar Pradesh: Capacity Building & Digitisation Initiatives

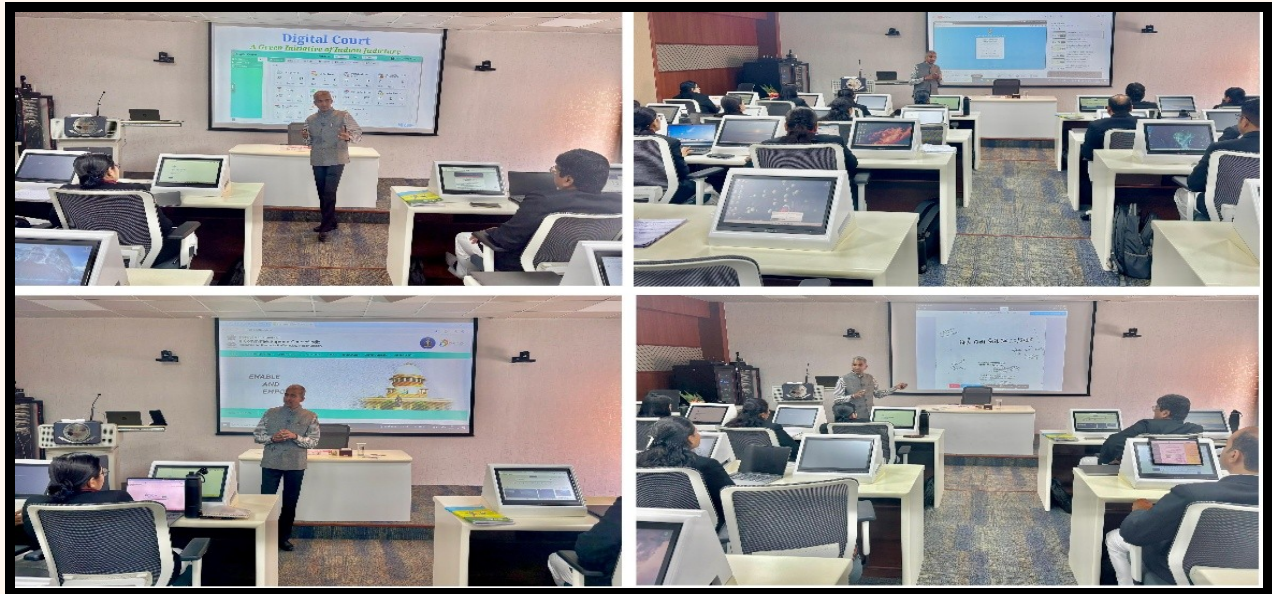


In **May 2026**, the Judicial Training & Research Institute delivered a series of impactful programmes designed to strengthen judicial capacity and support court digitisation. Two consecutive five-day offline training sessions (**ECT-14-2026**) were held from 11–15 May and 18–22 May, engaging 74 and 68 Judicial Officers from the Civil Judge (Senior Division) cadre.

Complementing this, on 24 May 2026, the Institute organised a

one-day online programme (**ECT-9-2026**) via Zoom, which trained 874 District Court staff from Record Rooms, Copying Sections, and Court Clerks involved in digitisation. Together, these initiatives highlight the Institute's commitment to continuous professional development and digital transformation, equipping both judicial officers and court staff with essential competencies for modern judicial administration.

Maharashtra Judicial Academy: Induction Training for Newly Recruited Judges



The **Maharashtra Judicial Academy** conducted two one-day training programmes on 20 May 2026. Under **ECT_17_2026**, a session was held offline at the Academy premises for **12** newly recruited Civil Judges, providing them with essential orientation and capacity-building. Simultaneously, **ECT_18_2026** was organized offline at the district level, engaging **13** newly recruited District Judges in tailored training to

strengthen their judicial preparedness. Both programmes were facilitated by Shri Nikhil A. Gupta, Judge, Labour Court, Satara, who served as the resource person, guiding participants through foundational judicial training. Together, these initiatives highlight the Academy's commitment to structured induction and professional development for the state's new judicial officers

Chhattisgarh State Judicial Academy: Extensive Online Training Outreach for Advocates

The Chhattisgarh State Judicial Academy rolled out *ECT_7_2026*, a wide-ranging series of one-day online training programmes during May 2026, aimed at enhancing the professional skills of Advocates and Advocate Clerks across the state.

Conducted through Google Meet, these sessions ensured uniform access to training while decentralizing delivery to the district level. Between **14–31 May 2026**, the Academy successfully reached participants in Ambikapur (20), Baikunthpur (11), Balod (11), Baloda-Bazar(15), Balrampur-Rganj (17), Bemetara (9), Bilaspur (10), Dantewara (17), Dhamtari (10), Durg (42), Jagdalpur (12), Janjgir-Champa (46), Jashpur (15), Kanker (30), Kawardha (7), Kondagaon (8), Korba

(27), Mahasamund (29), Mungeli (7), Raigarh (44), Raipur (8), Rajnandgaon (9), and Surajpur (7). With over 400 participants engaged across 23 districts, the initiative reflects the Academy's commitment to strengthening grassroots legal capacity.

By leveraging digital platforms, the Academy ensured inclusivity, enabling advocates from smaller districts to benefit from the same quality of training as those in larger centers. This extensive outreach underscores the Academy's vision of building a stronger, digitally empowered legal community in Chhattisgarh, fostering continuous professional development and bridging geographical divides.

Gujarat State Judicial Academy: Refresher Programme for Registry Staff



On **2 May 2026**, the Gujarat State Judicial Academy conducted **ECT-15-2025**, a refresher programme for the Registry Staff of the High Court of Gujarat. The sessions covered a wide range of topics including *change management, e-Courts initiatives, hardware components, operating systems, court-specific software, e-filing modules, video conferencing rules, server basics, digitization SOPs and technical assistance to courts and departments.*

Solanki, Mr. Vijaysinh Gohil, Mr. Nilesh Makwana, Mr. Pritesh Kachhia, Mr. Parth Ganatra, Mr. Rases Jani, Mr. Sanjaykumar Devmurari, Dr. Bhavin Jasani, Mr. Naresh Modhwadia, Mr. Pranav Joshi, Mr. Mehul Prajapati, Mr. Manish Patel, Mr. Gautam Rathod and Mr. Digvijay Solanki guided the participants. The programme emphasized continuous learning and digital capacity-building, reinforcing the Academy's motto that "*Learning has no end.*" A second batch in the afternoon followed a similar structure, beginning with registration, prayer and two introductory modules on change management and e-Courts initiatives, before moving into sessions on *hardware, operating systems, e-filing, video conferencing, digitization and technical support.*

The refresher programme highlighted the Academy's emphasis on continuous learning, digital transformation, and capacity-building for registry staff, ensuring they remain updated with evolving judicial technologies and practices.

Himachal Pradesh Judicial Academy: Dual Training Sessions

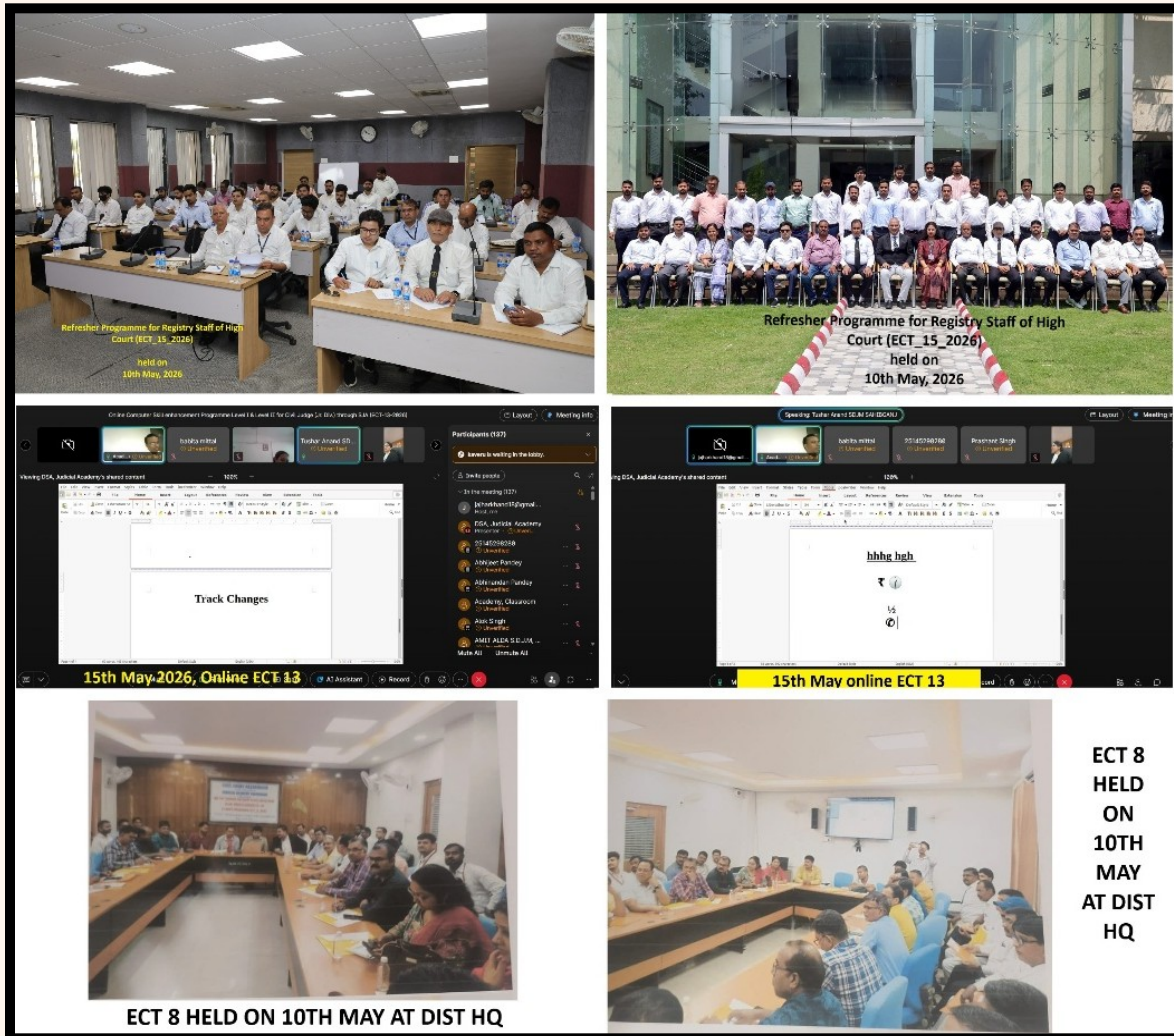
Target Digital Record-Keeping and ICT Tools



The Himachal Pradesh Judicial Academy continued its efforts to strengthen digital capacity and awareness among judicial officers and staff through specialized training programmes in May 2026. On 11 May 2026, the Academy organized the **ECT-06-2025** programme on Digitization of Records for 33 ministerial staff of the District Judiciary, focusing on modern record-keeping practices. and digital

documentation methods. Later, on 23 May 2026, the Academy conducted the **ECT-16-2025** training on ICT Awareness and eCourts Programme for Senior Civil Judges and Civil Judges, with 45 participants. This session was enriched by the guidance of Shri Aslam Beg, Senior Civil Judge-cum-CJM, Mandi, who shared practical insights into leveraging ICT tools and eCourts platforms for judicial efficiency.

Judicial Academy Jharkhand: Triple-Stream Training Boosts e-Filing, Case Management, and Registry Tech



On **10 May 2026**, the Judicial Academy Jharkhand organized two parallel one-day offline ICT training programs aimed at upgrading court administration and technical

workflows. The **ECT-15** session engaged 43 High Court Section Officers and Assistants at Seminar Hall 1, focusing on the registry's role in e-filing, computer infrastructure

overview (software/hardware, networking and servers), video conferencing, hybrid hearing setups, data management and paperless court tools like PDF applications. This training was conducted by a team of resource persons comprising Ms. Kumari Muskan, Raibata Chandra, Prince Kumar, Ashish Ranjan, Sai Sandeep and Vinay Koundal.

Simultaneously, the **ECT-8** program trained an impressive 828 participants across all District and Sub-Divisions including Administrative Heads, Nazarat staff, and Process Servers led by System Assistants (DSA) and Assistants of respective judgeships. This broad-based initiative emphasized change management, continuous stakeholder sensitization, the eCourts project mission, digitization processes, OS navigation, desktop/file management and productivity applications like MS

Word, LibreOffice, OpenOffice, and web browsers.

Further, on **15 May 2026**, the Academy conducted **ECT-13** in online mode via Webex. Led by Sri Bhaskar Kumar, this targeted one-hour session reached 134 Civil Judges (Junior Division) across all districts. The program concentrated on Case Management Systems (CMS), training judicial officers on digitization workflows, metadata entry, case management integration and the overall benefits and utilities of digital tools in day-to-day adjudication.

Together, these initiatives reflect the Judicial Academy Jharkhand's commitment to holistic capacity building across all judicial tiers, effectively pairing hands-on offline staff training with targeted online learning for judicial officers to maximize operational efficiency and accelerate paperless court adoption.

Manipur Judicial Academy: Training for Advocates and Clerks to Strengthen Legal Capacity



On **30 May 2026**, the Manipur Judicial Academy conducted **ECT-12-2026** in physical mode, engaging **85** participants comprising Advocates and Advocate Clerks. This one-day programme focused on strengthening professional skills and enhancing procedural understanding among legal practitioners.

By targeting advocates and their clerks, the Academy reinforced its commitment to capacity building within the legal fraternity, ensuring that frontline professionals receive practical, hands-on training to support the effective functioning of the justice system.

Meghalaya State Judicial Academy: Targeted Skill Training for Tura Legal Community



On **25 May 2026**, the Meghalaya State Judicial Academy, Shillong conducted two sets of programmes in physical mode.

The first, **ECT-11-2025**, was a 1.5-hour session for 15 staff members of the District & Sessions Court, Tura, focusing on strengthening administrative and procedural skills. On the same day, **ECT-4-2026** and

ECT-12-2026 were held as 1.5 hour sessions for 33 advocates from the Tura Bar Association, aimed at enhancing professional competence and practical legal understanding.

Together, these initiatives reflect the Academy's commitment to capacity building for both court staff and advocates.

Sikkim Judicial Academy: 3.5-Hour Online Master Training Programme for Master Trainers



On **30 May 2026**, the Sikkim Judicial Academy conducted **ECT_03_2026**, a Master Training Programme for New Master Trainers. The session was held in online mode via Zoom and spanned **three hours and thirty minutes**. A total of four participants attended this focused training initiative. The programme was enriched by the expertise of Mr.

Yoland Z. Christopher, Section Officer (System), District & Sessions Court, Gangtok, and Mr. Deependra Dixit, Section Officer (System), District & Sessions Court, Namchi. Their contributions provided valuable technical and practical insights for the participants.

Tripura Judicial Academy: Digital Transformation with Targeted eCourts Training for Advocates, Clerks and Staff



On **3 May 2026**, the Tripura Judicial Academy conducted *ECT_7_2026*, a series of half-day offline training programmes for Advocates and Advocate Clerks. The sessions were organized in multiple batches, with participation from 38, 36 and 46 attendees respectively, reflecting the Academy's effort to reach a broad group of legal practitioners.

Continuing its training initiatives, the Academy held *ECT_12_2026* on 17 May 2026. This was a one-day offline programme attended by 49 and 70 Advocates/Advocate Clerks across two sessions, providing comprehensive exposure to practical aspects of advocacy and court procedures.

Further, on **24 May 2026**, the Academy organized *ECT_15_2026*, a one-day offline programme specifically designed for 40 High Court staff. This session focused on enhancing administrative efficiency

and strengthening institutional capacity within the High Court system.

Together, these programmes underscore the **Tripura Judicial Academy's** commitment to professional development, offering structured training for both practicing advocates and court staff, thereby contributing to the overall improvement of the justice delivery mechanism.

By promoting greater awareness of ICT tools and encouraging the uniform implementation of eCourts applications, the initiatives contribute to improving efficiency, transparency, and accessibility in judicial administration. The programmes further advance the objectives of eCourts Phase III, supporting the vision of an integrated, interoperable, and digitally empowered justice delivery system.

Uttarakhand Judicial & Legal Academy, May 2026: Empowers Court Staff with Hands-On eCourts Digital Skills Training



The Uttarakhand Judicial & Legal Academy, Nainital organized three one-day training programmes under **ECT-8-2026** during May 2026.

All sessions were conducted in physical mode and focused on enhancing the skills of court staff. The first programme was held on **10 May 2026** with **75 participants**, followed by the second on **17 May 2026** attended by **71 participants** and the third on **24 May 2026** which saw **94 participants**. These initiatives underscore the Academy's commitment to strengthening the efficiency and professional capacity of court staff through structured training interventions.

The training programme focused on strengthening participants' practical understanding of recently introduced digital tools and workflows under the

eCourts ecosystem. Sessions covered machine scrutiny of Negotiable Instruments Act cases, generation and electronic service of civil and criminal processes through the N-Step platform, preparation and management of Roznama, integration with e-Prison, use of e-Sakshya for electronic evidence, e-Pay for digital court fee payments, Nyay Shruti and the e-Sign facility.

Participants from the Dehradun programme also received hands-on guidance on the digitization process and the witness statement module, while the Haridwar and Udham Singh Nagar programmes concluded with interactive discussions and query-resolution sessions to address operational challenges encountered during day-to-day court functioning.

High Court Tech Roadmap

High Court of Andhra Pradesh Advances Digital Transformation with New Mobile App, JASS Automation and Integrated Annotation Tools

High Court of Andhra Pradesh Mobile Application (Android & IOS)



The Flutter-based mobile application enabled the team to seamlessly host the same file on both the Google Play Store and the Apple App Store. Data for the application is sourced directly from the High Court's database through an API, which eliminates the

need for frequent manual updates. This integration ensures that the latest information is automatically reflected in the mobile application whenever updates are made to the official website of the High Court.

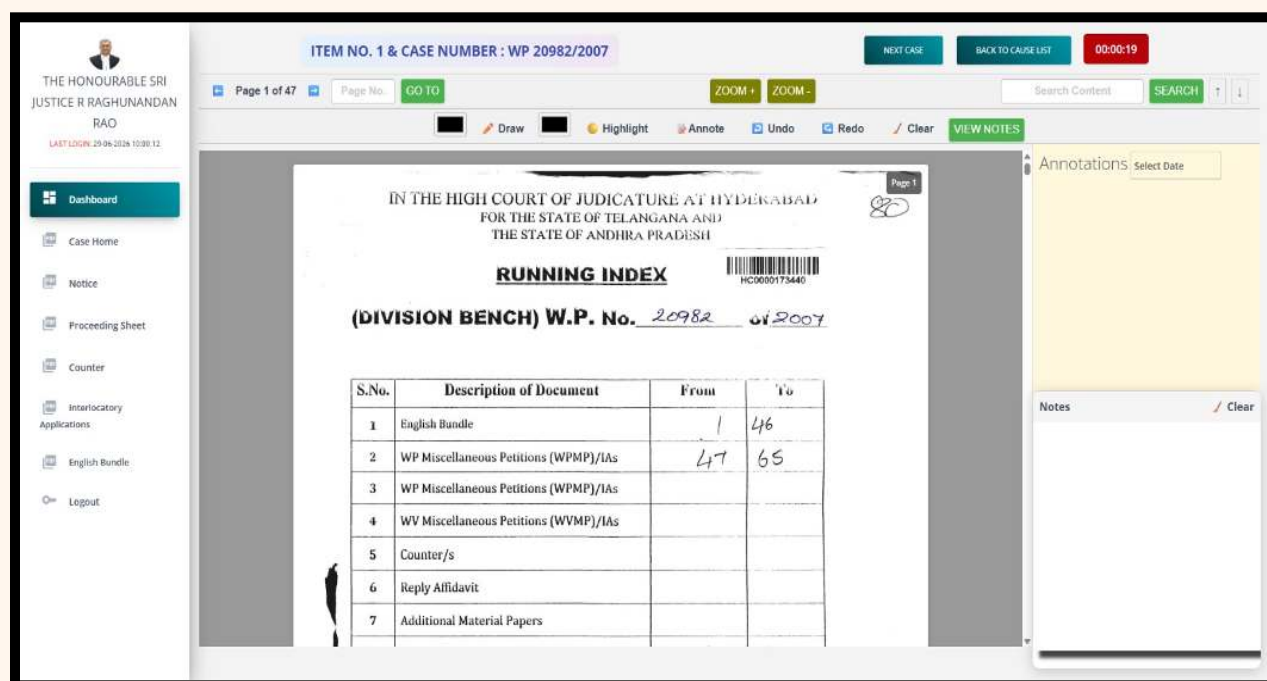

The **Judicial Assignment & Staffing System (JASS)** is a secure, centralized web application designed to automate the daily assignment of court staff based on the cause list chart and personnel availability.

It enables the Posting Section to capture and submit the daily chart. This data is then visible to Section officers of CM Section and CO Section for preparing and managing staff allotments, including

replacements in case of emergency leave. The system streamlines the existing process by providing a centralized platform for real-time management, improving efficiency, transparency, and accuracy. JASS will initially be implemented on a pilot basis on a local server within the High Court. After successful testing and approval, it will be hosted at the State Data Centre (SDC) for secure access.

New Integrated Annotation Tools Boost Digital Efficiency and Case Management for Legal Professionals



The integrated annotation tools allow users to highlight important passages, add notes, draw markings, undo or redo changes and clear annotations as required. These annotations are intended solely for personal reference during case preparation and do not alter the original judicial record.

The e-Initiative promotes efficient case management, improves accessibility, reduces paper consumption and supports advocates, litigants, and judicial officers in delivering faster and more effective digital court services.

Kerala High Court Advances ICT Infrastructure with New Auto Cause Listing, Automated Judgment Dashboard and Specialized Staff Training

Kerala High Court Modernizes Listing Process with New Auto Cause Listing System



With a view to enhance the ICT infrastructure of the Kerala High Court, the Auto Cause Listing System was successfully implemented in the High Court of Kerala on 18 May 2026. The system automatically generates cause lists based on case registration, postings, adjournments, urgent mentions and other predefined parameters, while

permitting limited manual intervention by the Listing Officers.

Various training programmes were conducted for the staff of the Judicial Section to ensure a smooth transition. At present, the High Court is successfully carrying out the auto-listing of cause lists through the new system.

To facilitate a smooth transition for the implementation of Auto Cause Listing System in the High Court training programmes were conducted for the Court Officers,

Listing Officers and staff of Judicial Sections on 16th May 2026 in two batches. The details of the participants are as under:

The Registrar (Judicial) and the Registrar (Computerization) of the High Court of Andhra Pradesh, along with three Joint Registrars and technical personnel, visited the High Court of Kerala from 12.05.2026 to 15.05.2026. The purpose of the visit was to study and understand the IT

infrastructure, technical framework, structural and functional hierarchy and operational workflows of the High Court of Kerala's IT wing, with a view to adopting and implementing similar systems and best practices in the High Court of Andhra Pradesh.



New Dashboard Modules Introduced to Automate Judgment Drafting and Streamline Judge Management

1. *Judgment Generation Module:*

A new Judgment Generation module has been introduced in the Judge Dashboard to facilitate faster and seamless preparation of judgments. The module displays cases in which

the judgment has not yet been drafted or uploaded. By selecting the Generate Order option, the judgment opens in the Template Editor with relevant case and order details automatically populated from the system as of the date of decision.

Judges can review, modify, finalize, and digitally sign the judgment directly through the system, enabling secure and authenticated issuance of judgments.

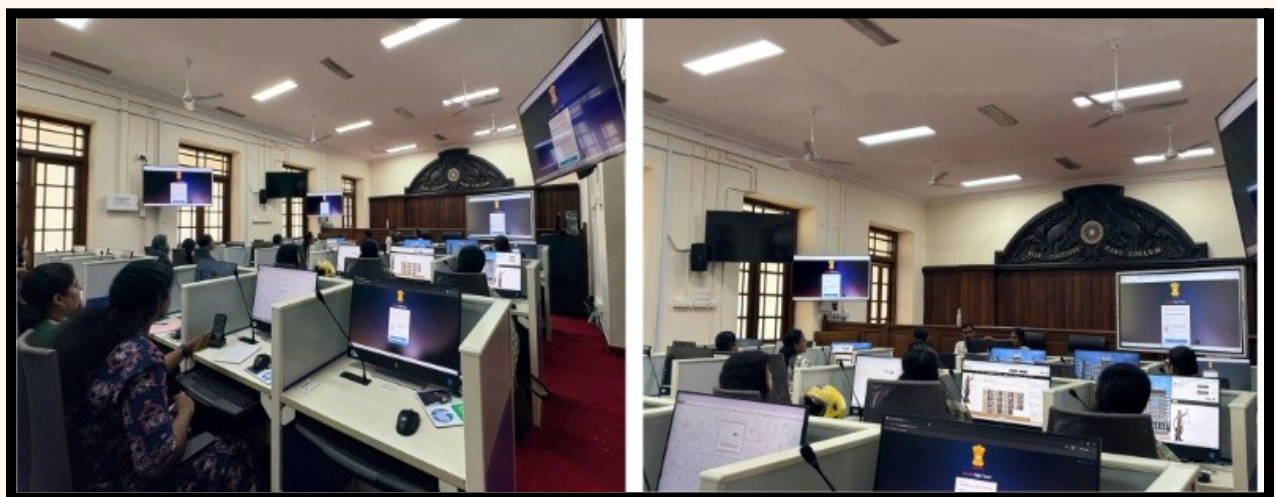

As part of its continuous digital transformation and ICT enablement drive, the High Court of Meghalaya has developed a periphery module designed to embed dynamic QR codes into pending court orders.

This feature equips the system with provisions for orders to be digitally signed by the concerned judicial authorities, ensuring the authenticity, tamper-proof

integrity, and swift verification of judicial records.

To ensure seamless adoption, institutional readiness and operational efficiency across court proceedings, a comprehensive hands-on training program on the operation and utility of this periphery module was organized for Private Secretaries and Stenographers.

Rajasthan High Court Initiatives: Establishment of E-Seva Kendra at three locations



To enlarge citizen centric Services and facilitate Advocates, Litigants and other stakeholders, digitally equipped “**e-Seva Kendra**” have been established at 3 new locations i.e. Churu Court Complex, Hanumangarh.

Rawatsar Court Complex and Jodhpur Metro Court Complex (**Old Heritage Building**) at three Judgeships. Various digital services i.e. video conferencing, enabling

advocates and litigants to participate in proceedings from any remote locations, case status, cause lists, orders/Judgments, e-filing and e-payment services are being provided through these e-Seva Kendras.

All three e-Seva Kendras were inaugurated and became operational in the month of May.
