(c) Supplier shall have to submit self attested copies of last three years Income Tax Return, Sales Tax Clearance Certificate, Sales Tax Registration Certificate, VAT Number and Permanent Account Number (PAN) with copy thereof has to be furnished.

(d) A certified copy of the P&L account and Balance Sheet, showing the Gross Turnover for the previous year which shall not be less than Rupees One Crore.

(e) Evidence for having supplied products to Central Government Departments / Public Sector undertaking in the last one year.
