The candidates selected for interview are approximately three times the number of vacancies category wise. In case of SC category, adequate number of candidates could not qualify in terms of the cut-off marks of 50% in the said online examination.

The information regarding date, time & venue of interview as well as call letters for interview will be uploaded later on. The candidates are advised to keep visiting the website of the Court for further details / updates.

The aforesaid qualified candidates are requested to upload the scanned copies of documents in the prescribed format given below for first stage verification -


- a) Application form submitted online.
- b) Matriculation certificate / School Leaving Certificate showing date of birth.
- c) Certificate & Marksheet of M.B.A. Degree or equivalent with Human Resources / Personnel Management as the optional or as one of the Principal subjects, awarded by a recognized University or an institution recognized by UGC/ AICTE.
- d) Certificate showing requisite experience of atleast one year in a reputed organization in the field of Office Management.
- e) Good conduct certificate from the last employer
- f) Self declaration of criminal antecedent or pending criminal case, if any, on affidavit.
- g) Caste Certificate issued by D.M./S.D.O. as applicable in support of category as filled in their online application form.
- h) Residential / Domicile Certificate of Bihar, in case of claiming reservation.

For the aforesaid purpose, the link of the website of the Court shall remain open from **25.02.2017** till midnight of **20.03.2017**.

The candidates coming for the interview would be required to bring their call letter for interview downloaded from the website of the Court and original documents, scanned copies whereof they have already uploaded as mentioned above. Failure to produce the original documents would disqualify them from appearing at the interview.

Note : The interview will be of 25 marks with cut-off of 10 marks. The final select list would be prepared on the basis of the aggregate of marks obtained in the online examination and in the interview.
