COMPUTER OPERATOR-CUM-TYPIST RECRUITMENT EXAMINATION, 2022

The final result for appointment to the post of Computer Operator-cum-Typist under Advertisement no.PHC/02/2022 for Computer Operator-cum-Typist Recruitment Examination, 2022 is being published alongwith this notice for information to all concerned. The candidates must take notice of following facts which have been taken into consideration for preparation of final result:

1. Total 84 candidates who had attained the minimum qualifying standard in the Computer Based Written Test comprising Multiple Choice Question based Objective Test, English Computer Typing Test and Hindi Computer Typing Test as prescribed in the clause 7 (i), (ii) & (iii) of the Advertisement no.PHC/02/2022 were called for appearing in the interview.
2. The candidates who have attained the minimum qualifying standard in the interview as prescribed in the clause 7 (iv) of the Advertisement no.PHC/02/2022 have been considered for preparation of final result. The marks obtained by a candidate in the Computer Based Written Test alongwith marks obtained in the interview have been taken into consideration.
3. Candidates securing marks equal and above the marks secured by the last candidate selected in Unreserved Category have been placed in the Unreserved Category while other candidates have been placed in their respective category of reservation.
4. Pursuant to the order dated 21.02.2022 passed in Writ Petition (Civil) No. 1052 of 2021 by the Hon'ble Supreme Court, the notification number 689 dated 23.08.2016 issued by the Government of Bihar vide which the benefit of Scheduled Tribe Category was extended to the "Lohar" community, has been quashed. Subsequently, a notification vide memo No. 6026 dated 19.04.2022 has been issued by the General Administration Department, Government of Bihar stating therein that the benefits of Extremely Backward Classes (EBC) as extended to the "Lohar" community prior to issuance of the quashed notification, shall continue. Accordingly, all the candidates of "Lohar" Community have been considered under Extremely Backward Classes (EBC).

5. If two or more candidates have secured equal marks, the candidate securing higher marks in the written test has been placed above and if the marks obtained in the written test are also equal, then the candidate born earlier has been placed above.
6. The result has been prepared after following the 100 point roster-reservation policy adopted in the establishment of Court at the time of advertisement. The names of candidates are in order of merit and their category of selection is indicated against their names at Annexure-I.
7. The prepared result comprises 12 candidates under UR Category including 04 female candidates, 03 candidates of EWS Category including 01 female candidate, 04 candidates under BC Category including 01 female candidate and 01 OH candidate, 05 candidates under EBC Category including 02 female candidate, 05 candidates under SC Category including 02 female candidates & 01 candidate under ST Category.

Out of total 30 candidates, 01 candidate of OH Category has been horizontally placed in his respective category.

8. The Cut-Off marks for each category is as follows:
