Under Rule 25 of the Bihar Civil Services (Judicial Branch) (Recruitment) Rules, 1955, amended as per the Bihar Civil Service (Judicial Branch) (Recruitment) (Amendment) Rules 2005, these temporary Civil Judges (Junior Division) shall have to undergo training for the post as if they are appointed on a substantive basis.

The District and Sessions Judges should see that the temporary Civil Judge (Junior Division) posted in their Judgeships as above shall take training as per the Rule 11 and 24 of the Bihar Civil Service (Judicial Branch) (Training and Departmental Examination), Rules, 2019 as amended upto date.

The District and Sessions Judges are directed to verify the photograph affixed and attested on appointment letter issued by General Administration Department, Government of Bihar, Patna and their appointment will not be accepted on the event that they do not produce it at the time of joining. Further, verify the certificates regarding educational qualification, date of birth, reservation quota etc. of the concerned Civil Judges (Junior Division) before they assume charge of the post.

The appointment of Ms. Pranjali Prakash named at serial no. 22 of aforesaid table shall be accepted only after she presents original certificate of graduation at the time of joining.

The appointment of Sri Sunil Kumar Verma named at serial no. 49 of aforesaid table shall be accepted only after he presents NOC of his office at the time of joining.

The appointment of Sri Om Prakash named at serial no. 107 of aforesaid table shall be accepted only after he presents NOC of his office at the time of joining.

The appointment of Sri Jay Prakash Mahto named at serial no. 170 of aforesaid table shall be accepted only after he presents a certificate showing recognition of his Educational Institution by Bar Council of India at the time of joining.

The District and Sessions Judges are hereby informed that the Court have decided that joining the post by the candidates should be within a fortnight from the date of receipt of the Court's Notification. The period of joining for those candidates, already in any other service shall be one month from the date of receipt of the Court's Notification. Further, the District and Sessions Judges are directed to strictly ensure the requirement of prior written permission before a Judicial Officer leaves station failing which the Court may like to consider the matter appropriately.
