### **Final Result of the District Judge (Entry Level), Direct from Bar Exam-2021**

1) The aforesaid result has been prepared on the basis of provisions as contained in Advertisement No. BSJS/1/2021, The Bihar Superior Judicial Service Rules, 1951, letter number 588 dated 17.01.2017 & 469 dated 11.01.2021 issued by the General Administration Department, Govt. of Bihar to the Patna High Court and other authorities and also communication made to the Court by the State Government vide memo no. 12033 dated 18.09.2017 & letter no. 127 dated 05.01.2022 regarding roster formula applicable in respect of reserved Category candidates.

- 3) No candidate in ST category could obtain qualifying marks at the stage of Preliminary Test. Further, one post of EBC has been kept vacant in view of Order dated 26.07.2023 passed by the Hon'ble Patna High Court in CWJC No. 10432 of 2023.
- 4) Only one candidate could obtain qualifying marks against 7 vacancies reserved for SC category. Further, 3 backlog vacancies of SC category of the District Judge (Entry Level), Direct from Bar Exam-2019 has been filled up from the candidates of Unreserved category after dereserving them in view of the aforesaid Rules, 1951.
- 5) One candidate having Roll No. 11207, has filled in his online application form his category as 'EBC' while he produced caste certificate of 'BC' on the date of interview. On account of his non-producing the Caste Certificate of EBC as claimed by him in spite of extended time, his candidature for District Judge (Entry Level), Direct from Bar Exam-2021 is being rejected.
- 6) Another candidate having Roll No. 11759, has been declared disentitled for appointment as Additional District & Sessions Judge as he is Manager (Law) under NHPC Ltd.
- 7) A Tabular Chart containing relevant details alongwith marks obtained in Main (Written) Examination and interview (viva voce test), in respect of all the candidates, who were called for interview except the abovenamed is enclosed herewith. In the said chart, "Qualified" column specifies whether the candidates obtained minimum qualifying marks or not.
- 8) Category wise merit list of finally selected candidates, in detail, is also enclosed herewith.
- 9) Further, the candidates of select list, with curable defects in their applications / documents, will have to rectify the defect(s) within a fortnight from the date of result failing which recommendation for appointment in respect of them would be liable to cancelled. The details of such candidates are also uploaded on the website of the Court.
- 10) The marks obtained by all the candidates who appeared in the Main (Written) Examination will also be uploaded on the website of the Court soon.
