On the basis of performance in the Shorthand Computer Typing Test (Main) for the **Personal Assistant Recruitment Examination, 2023** (under Advertisement No. **PHC/03/2023**) held on 30.03.2024 (Saturday) in single shift at the examination centre in **Patna**, total 84 candidates are hereby declared qualified for appearing at the Interview for selection/ appointment to the post of Personal Assistant in the establishment of this Court.

Candidates who have attained minimum qualifying criteria in the Shorthand Computer Typing Test (Main) (as prescribed in the Advertisement) have been taken into consideration (merit-wise) for preparation of the result in the ratio of three times against vacancy advertised in each category of reservation, as per their availability.

The candidates will be required to produce the original certificates in support of their claims pertaining to Age, Minimum Qualification/ Eligibility Condition, Domicile Certificate, Non-Creamy Layer (NCL) Certificate/ Caste Certificate/ Income & Asset (EWS) Certificate etc., at the time of document verification before their Interview.

Interview is tentatively scheduled to be held on 25.04.2024 (Thursday) and 26.04.2024 (Friday) in the premises of Patna High Court. The Admit Card/ Interview Letter for appearing at the Interview will be made available in due course, which may be downloaded from the official website of the High Court i.e. www.patnahighcourt.gov.in.
