On the basis of performance in the computer based written test comprising Multiple Choice Question based Objective Test for the **Foreman (Motor Car Garage) Recruitment Examination, 2024** (under **Advertisement No. PHC/03/2024**) held on 24<sup>th</sup> August, 2024 (Saturday) in single shift in Patna, total 06 candidates are hereby declared qualified for appearing at the Foreman Skill Test & Interview for appointment to the post of Foreman (Motor Car Garage) in the establishment of this Court.

They are, therefore, advised to keep the said documents ready with them.

The date and schedule of Foreman Skill Test of these candidates will be announced shortly on the official website of the Court. The Admit Card for appearing at the Foreman Skill Test will be made available in due course, which may be downloaded from the official website of the High Court i.e. <https://patnahighcourt.gov.in>. Admit Card would not be sent to the candidates separately through any other mode.

No request for change in the schedule of Foreman Skill Test shall be entertained.
