2. The Officers shall report at the examination centre one hour before the commencement of the examination on each day of the examination.
3. No electronic gadgets are allowed in the Examination Hall.
4. The candidates are allowed to carry their own books for Paper – I (Civil Court Rules and Criminal Court Rules) only ensuring that there is no identification mark of any type on the books.
5. The candidates who will appear in the examination are allowed to leave the station of their posting after first half on 09th May, 2025 and the Officers undergoing training at the Bihar Judicial Academy shall remain exempted from training on 10th and 11th May, 2025.
6. The candidates must fill-up the format enclosed with this notice and bring it with them at the time of examination.
7. Other directions with regard to the examination has already been communicated vide the Court's earlier notice dated 07.03.2025.
