The Member Secretary, Bihar State Legal Services Authority, Budh Marg, Patna is hereby requested to take endeavor to expedite the 40 Hours Mediation Training Programme in respect of aforesaid newly empanelled Mediators and after training, the list of Trained Mediators may be shared with the office of Patna High Court Mediation Centre, Patna for further action.

Further, it is informed that the commencement of period of three years in respect of newly empanelled Mediators shall be counted from the date of empanelment.
